Aqua (CAS N°: 7732-18-5), 2,6-bis(1,1-dimetil-etil)-4-metil fenol (CAS N°: 128-37-0), 2-metil-4-isotiazolona-3 (N°CAS:: 2682-20-4), PEG-40 Hydrogenated Castor Oil (N° CAS: 61788-85-0), Trideceth-9 (N° CAS:24938-91-8), Propylene Glycol (N° CAS: 57-55-6), Dipropylene Glycol (N° CAS: 25265-71-8), fragrances.

**2. Hazardous components:**

Disodium EDTA (CAS N°: 139-33-3), Alcohol (CAS N°: 64-17-5), 5-cloro-2-metil-4-isotiazolona-3 (N° CAS: 26172-55-4).
